**Invitation to Bid for**

***SUPPLY AND DELIVERY OF 240 HEADS WEANED PIGLETS AND 480 BAGS***

***FEEDS HOG GROWER, GUIUAN E. SAMAR***

1. The *Local Government Unit of Guiuan* through the *Trust Fund* intends to apply the sum of One Million Nine Hundred Twenty Thousand Pesos only (Php 1,920,000.00), the Approved Budget for the Contract (ABC) to payments under the contract for *SUPPLY AND DELIVERY OF 240 HEADS WEANED PIGLETS AND 480 BAGS FEEDS HOG GROWER, GUIUAN E. SAMAR*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Local Government Unit of Guiuan* now invites bids for *SUPPLY AND DELIVERY OF 240 HEADS WEANED PIGLETS AND 480 BAGS FEEDS HOG GROWER, GUIUAN E. SAMAR*.<sup>1</sup> Delivery of the Goods is required 20 days after notice to proceed. Bidders should have completed, within *20 days* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
3. Interested bidders may obtain further information from *SUPPLY AND DELIVERY OF 240 HEADS WEANED PIGLETS AND 480 BAGS FEEDS HOG GROWER, GUIUAN E. SAMAR* and inspect the Bidding Documents at the address given below from 16 October 2020 – 04 November 2020 from 8:00 AM – 5:00 PM. On the bid opening date only until the time of the bid opening.
4. A complete set of Bidding Documents may be acquired by interested bidders on from the address below and upon payment of a nonrefundable fee of Php 5,000.00 for the Bidding Documents.  
  
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
5. Bids must be duly received by the BAC Secretariat at the address below on or before 04 November 2020 from 8:00 AM – 2:00 PM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on 04 November 2020, 2:00 PM at *the BAC Office, LGU-Guiuan*. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
