#### EXECUTIVE ORDER NO. 06-3/- s. 2021

# AN EXECUTIVE ORDER DECLARING AND STRENGTHENING THE GUIDELINES FOR THE INSPECTION AND PAYING OF INSPECTION FEES FOR DELIVERY PANELS OF DRESSED CHICKEN AND PORK

WHEREAS, Section 16, the General Welfare clause of the Local Government Code of 1991, otherwise known as R.A. 7160, mandates the Local Government Units to "promote the health and safety of its inhabitants;"

WHEREAS, Republic Act No. 11469 otherwise known as the "Bayanihan to Heal as One Act" was approved mandating all local government units to adopt and implement measures to prevent further spread of COVID-19 and ensure safety and well-being of all;

WHEREAS, the Municipality of Guiuan, Eastern Samar is under the Modified General Community Quarantine;

WHEREAS, Guiuan Inter-Agency Task Force(GIATF) passed Resolution No. 01, 2020, providing for the necessary measures and responses to prevent the spread and transmission of the disease in Guiuan:

WHEREAS, the Municipality of Guiuan, Eastern Samar is now implementing the approved revised Revenue Code of the Municipality under Resolution No. 25, s. 2019;

**WHEREAS**, there is a need to implement protocols for the entry of delivery panels to the Municipality of Guiuan amid the pandemic;

**NOW THEREFORE, I ANNALIZA P. GONZALES-KWAN,** Municipal Mayor in the Municipality of Guiuan, Eastern Samar, by virtue of the powers vested in me by law, do hereby order:

Section 1. Securing of Entry Pass and Exit Pass. All Delivery Panels of Dressed Chicken and Pork coming from outside of Guiuan shall:

- a) Secure an Entry Pass signed by an authorized personnel at the Guiuan border upon entry to the Municipality of Guiuan;
- b) Secure an Exit Pass signed by the Meat Inspector located at the Office of the Economic Enterprise Development and Management Services (OEEDMS) after inspection and payment of sales.

This Exit Pass shall be inspected at the Guiuan Border upon exiting the municipality.

#### Section 2. Delivery of Dressed Chicken and Pork.

- a) Delivery Panels are prohibited to deliver their commodities to stores/vendors and are required to stay only at Guiuan Integrated Transport Terminal. They shall conduct canvassing through text or call.
- b) Stores with "booking" shall pick-up their commodities at the Guiuan Integrated Transport Terminal. Delivery Panels shall inform the stores of their arrival and ensure that preventive measures are in place to prevent close contact between the vendors and the panel crew.

 Local chicken and meat vendors must proceed to the Guiuan Integrated Transport Terminal to purchase meat.

**Section 3.** *Guidelines for Delivery Panel Crew*. All Panel Crew (driver/s, delivery/sales agent, helpers) must:

- Wear their proper uniforms and IDs, including Health ID for proper identification;
   and
- b) Comply with the minimum health protocols:
  - 1. Wearing of face masks and face shields;
  - 2. Observance of the 1-meter physical distancing;

**Section 4.** *Penalties* – Non-compliance of this Executive Order shall be penalized under the provisions of R.A. 11332, that provides for non-cooperation of persons and entities that should report and/or respond to CoViD-19 suspected and confirmed cases.

Further, if the offense is committed by a public or private health facility, institution, agency, corporation, school, or other juridical entity duly organized in accordance with law, the Chief Executive Officer, President, General Manager, or such other officer in-charge shall be held liable. In addition, the business permit and license to operate of the concerned facility, institution, agency, corporation, school, or legal entity shall be cancelled.

Section 5. Separability – In any event that any provision of this Executive Order or any part hereof is declared invalid, contrary to law, or unconstitutional, the provisions not thereby affected shall remain in force and effect.

**Section 6.** Repeal – All other issuances or parts thereof inconsistent with the provisions of this Executive Order are hereby repealed or amended accordingly.

**Section 7.** *Effectivity* – This Executive Order shall take effect immediately and shall remain to be in force until amended, modified or repealed, in whole or in part by subsequent national and/or local government issuances.
