EXECUTIVE ORDER NO. AGK06-33SERIES OF 2021

AN EXECUTIVE ORDER DECLARING THE RESTRICTED ENTRY TO BARANGAY CAMPOYONG DURING THE FEAST DAY OF STS. PETER AND PAUL (CAMPOYONG FIESTA) ON JUNE 29, 2021

WHEREAS, it is a declared policy of the State to uphold the people's constitutional rights to life, health, safety and property and to promote the general welfare of its people at all times;

WHEREAS, Section 16 of the Local Government Code of the Philippines mandates local government units to exercise power necessary, appropriate or incidental for the promotion of general welfare, health and safety of their inhabitants;

WHEREAS, Republic Act No. 11469 otherwise known as the "Bayanihan to Heal as One Act" was approved mandating all local government units to adopt and implement measures to prevent further spread of COVID-19 and ensure safety and well-being of all;

WHEREAS, the Municipality of Guiuan, Eastern Samar is under the Modified General Community Quarantine;

WHEREAS, the Department of Interior and Local Government issued Memorandum Circular No. 2021-058 dated May 31, 2021, mandating all LGUs to intensify regulation or prohibition of holding of activities as sources of virus superspreaders, which was further emphasized in the Regional IATF's Resolution No. 25 dated June 4, 2021.

WHEREAS, there is a need to implement protocols for events such as *fiesta* that may encourage mass gathering and activities as sources of virus superspreaders.

WHEREAS, the Local Government of Guiuan is committed to protecting and ensuring the safety and security of all Guiuananons;

NOW, THEREFORE, I, ANNALIZA P. GONZALES-KWAN, Municipal Mayor of Guiuan, Eastern Samar, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. *Restricted Entry to Barangay Campoyong during the Campoyong Fiesta.* The Municipal IATF and Barangay Campoyong have declared that the entry to Barangay Campoyong during the Campoyong Fiesta on June 29, 2021 from 8:00 AM to 8:00 PM shall be restricted.

Visitors who may enter the barangay are limited to:

1. Priests and their companions;
2. Choir Members;
3. Persons delivering essential goods and services;
4. Persons with work within Barangay Campoyong;
5. Persons with immediate families in Barangay Campoyong.

Section 2. *Activities not Allowed in Barangay Campoyong during the Fiesta.* Activities not allowed to be conducted within Barangay Campoyong on June 29, 2021 during the Fiesta are as follows:

1. Mass Gathering (e.i., dancing or *saroyaw*)
2. Karaoke or videoke

Section 3. *Liquor Ban.* Selling of alcohol and drinking in public places shall be prohibited on June 29, 2021. The Municipal IATF discourages friends and relatives from different households from engaging in drinking sessions to curb the transmission of COVID-19.

Section 4. *Penalties* – Non-compliance of this Executive Order shall be penalized under the provisions of R.A. 11332, that provides for non-cooperation of persons and entities that should report and/or respond to CoVID-19 suspected and confirmed cases.

Further, if the offense is committed by a public or private health facility, institution, agency, corporation, school, or other juridical entity duly organized in accordance with law, the Chief Executive Officer, President, General Manager, or such other officer in-charge shall be held liable. In addition, the business permit and license to operate of the concerned facility, institution, agency, corporation, school, or legal entity shall be cancelled.

Section 5. *Separability* – In any event that any provision of this Executive Order or any part hereof is declared invalid, contrary to law, or unconstitutional, the provisions not thereby affected shall remain in force and effect.

Section 6. *Repeal* – All other issuances or parts thereof inconsistent with the provisions of this Executive Order are hereby repealed or amended accordingly.

Section 7. *Effectivity* – This Executive Order shall take effect immediately and shall remain to be in force until amended, modified or repealed, in whole or in part by subsequent national and/or local government issuances.
