EXECUTIVE ORDER NO. AGK-01-01 S. 2022

AN EXECUTIVE ORDER SUSPENDING THE THIRD YEAR IMPLEMENTATION OF REGULATORY FEES AND OTHER FEES IN THE APPROVED REVENUE CODE OF THE MUNICIPALITY OF GUIUAN

WHEREAS, the Sangguniang Bayan of Guiuan issued Resolution No. 56, Series of 2020, Authorizing the Local Chief Executive to Constitute a Technical Working Group to Formulate the Implementing Rules and Regulations (IRR) of the Revenue Code of the Municipality of Guiuan, Eastern Samar;

WHEREAS, in the Implementing Rules and Regulations of the Revenue Code of the Municipality of Guiuan, certain fees have been adjusted by implementing and imposing the fees in three (3) tranches such that they are spread in three (3) years and the full amount in the Ordinance shall be collected starting in Year 3 to cushion the effect of the pandemic to the business sector and the economy in general;

WHEREAS, there had been appeals for reconsideration on the implementation of the approved and effective Revenue Code of Guiuan this year 2022 due to the continued negative impacts of COVID-19 and African Swine Fever on businesses and agricultural products;

WHEREAS, the Local Government Unit of Guiuan empathizes with the concerns of the business community that the increase of fees based on the Revenue Code this F.Y. 2022 will greatly affect their businesses;

WHEREAS, for humanitarian consideration and to revive the economy of Guiuan, the Local Government Unit of Guiuan deems it necessary that the implementation of the Implementing Rules and Regulations (IRR) for the Revenue Code for 2022 be suspended in light of the ongoing difficulties brought by the pandemic and the African Swine Fever (ASF);

NOW, THEREFORE, I, ANNALIZA P. GONZALES-KWAN, Municipal Mayor of Guiuan, Eastern Samar, by virtue of the powers vested in me by law, do hereby order the following:

Section 1a. Suspension of the implementation of the third tranche (Year 3) of the following fees based on the Revenue Code:

- a. Regulatory Inspection Fees
- b. Registration and Transfer Fees on Large Cattle
- c. Market Fees and Charges
- d. Rental Fees
 - PAG-IBIG Building Rates
 - Premium Building Rates
 - Municipal Building Rates
 - Stalls
 - Fish Section
 - Meat Section
 - Chicken Section
 - Laray Section

e. Slaughterhouse Fees

1.b. Collection of fees listed in Section 1a for F.Y. 2022 shall be based on the computation from the previous year (2021). Please see Annex 1 for the computation of fees.


Section 2. Separability – In any event that any provision of this Executive Order or any part hereof is declared invalid, contrary to law, or unconstitutional, the provisions not thereby affected shall remain in force and effect.

Section 3. Repeal – All other issuances or parts thereof inconsistent with the provisions of this Executive Order are hereby repealed or amended accordingly.

Section 4. Effectivity – This Executive Order shall take effect immediately and shall remain to be in force until amended, modified or repealed, in whole or in part by subsequent national and/or local government issuances.
